Results of Analysis

No spermatozoa were detected on the vaginal smear slide.

A presumptive test for the presence of semen was negative on the saliva specimen, vaginal, control, and extra swabs, and stains on the panties, tank-top, and overalls.

No significant trace evidence was detected in the fingernail scrapings.

No visually apparent foreign hairs were detected on the pubic hair combings.
