

Part 1 of your open records request states that you are requesting: *Hard copies of any and all e-mails sent from or received on any computer located inside the Sheriff's Department that mention Royce Abbott's name, including hard copies of any attachments.*

Upon your request, all Red River County Sheriff's Office e-mail accounts were disabled to insure that there was no loss of information and all these accounts were examined and no e-mails were found which contained the name of Royce Abbott.

Part 2 of your open records request states that you are requesting: *Hard copies of any and all correspondence sent from, or received by any official, or peace officer in this department, including copies of the envelopes.*

This portion of your request has been forwarded to the Red River County District Attorney's Office on 4/17/06 for an official opinion due to the broadness of the request and due to the possible exception of this information as a public record due to information that may be considered to be confidential by law, either constitutional, statutory, or by judicial decision. Therefore, I feel that an Attorney General's opinion would be appropriate to serve in the best interest of third parties, from the disclosure of information that may be considered "private" (under the law if it contains highly intimate or embarrassing facts about a person's private affairs such that its release would be highly objectionable to a reasonable person or if it concerns the more intimate aspects of human affairs, such as medical matters, marriage, procreation, family relationships, etc.).

Part 3 of your open records request states that you are requesting: *Names of any officials or peace officers obtaining criminal history on Royce Daniel Abbott using any method, and the justification thereof.*

This portion of your request has been forwarded to the Red River County District Attorney's Office on 04/17/06 for an official opinion due the Law Enforcement

Exception of the Public Information Act which exempts from required public disclosure any records relating to the detection, investigation, or prosecution of a crime for which there has been no conviction.

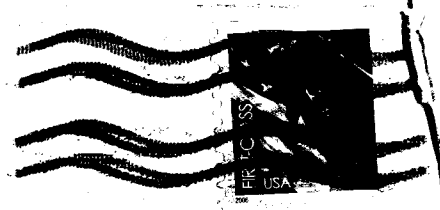
